

Website Terms and Conditions of Use

This document contains the general and specific terms and conditions governing access to the site www.somsight.com or any other site accessed through a link owned by ECHEZ (accessed through the Website). Using Website requires that the User is over 18 years of age, with legal capacity to contract without any impediment under the law. The User (hereinafter, User, Users, You as applicable) fully accepts the Terms and Conditions of Use of the ECHEZ Website (hereinafter Terms and Conditions) when using this Website. This Website is maintained by ECHEZ Inc (hereinafter, ECHEZ), with an address 1825 MAIN ST. WE WESTON, FL 33326, and its use is subject to the terms of this and the complementary and subsidiary conditions determined by the ECHEZ company and informed to Users through this Website, which includes the Data Protection and Privacy Policy, which is an integral part of these Terms and Conditions. Any visitor who gains access to the Website, occasionally or frequently, or uses any of the services provided through the Website, or registers to receive services through the Website, grants consent to these Terms and Conditions, in addition to the terms and conditions of the actual ECHEZ Services, to which the User will grant consent separately.

Conditions to Access the Website

The User acknowledges and accepts that these Terms and Conditions establish a bilateral contract for the access of the Website, formed using such Website by User, and based on the reciprocal communications and messages exchanged by the parties, through the communication tools provided through the Website. This contract's guiding principles, shall include good faith and the duty of mutual collaboration between the User and ECHEZ. Access is only available to natural persons who (i) are over eighteen (18) years of age, and (ii) have legal capacity to contract. Therefore, the Website may not be used by minors, or individuals temporarily or permanently banned by law to enter into a contract. ECHEZ, at any time and at its sole discretion, may order the temporary or definitive suspension or disqualification of any User and prevent User's access to the Website, and should this occur, ECHEZ will not be liable to the User or to any third party for any reason, under any circumstances.

Website Usage

User acknowledges that ECHEZ has the exclusive power to establish limits and conditions for Website usage, along with full and absolute discretion to publish, remove and / or modify any content on the Website. ECHEZ shall not be liable to the User or to any third party for damages or any other infringement to any rights, whether intellectual property rights, damage to the honour and reputation of a person, their personal data, credit, consumer rights, or any other right that may be infringed as a consequence of the misuse of the Website by a User. User accepts that ECHEZ, in its own discretion, may access, preserve, delete and modify the information in its Account and all content found on the Website. The User agrees that ECHEZ may cancel, delete or block User's registration on the Website at its sole discretion, without justification or prior notice and that this will not give User the right to claim any compensation. The User agrees that ECHEZ reserves the right to modify in any way, discontinue, interrupt, cancel and / or terminate the service of the Website without any justification or prior notice, in its sole discretion and that this will not give rise to a claim for compensation.

User Responsibility for Use and Contents

User shall be solely responsible for its use of the Website, as well as the information and contents included therein. Without being considered an exhaustive or limitative description, User is prohibited from publishing or transmitting any content that constitutes a violation of the rights of third parties or of their privacy, honour, self-image, confidentiality, intellectual and industrial property or protection of personal data, also prohibited to publish, disclose, announce, refer to or distribute any material, subject matter or information with illegal, obscene, pornographic, abusive, defamatory, deceptive, racist, against morals, good customs, or public order content; introduce any type of computer virus, defective files, or any other software or computer program that may cause damage or unauthorized alterations to the contents, programs or systems accessible through the Website; alter or intervene, by fraudulent means, personal web sites or emails of other Users without due authorization, as well as sending emails of a repetitive character, and sending email addresses of third parties without the due consent of those; alter or intervene, by fraudulent means, personal web sites or emails of other Users without due authorization, defame, insult, harass, stalk, threaten or infringe in any other way the rights of third parties (such as the right to privacy or to own image); publish, distribute or disclose any information or material that is inappropriate, sacrilegious, defamatory, illicit, obscene, indecent, racist, that induces violence or that may be considered illegal; advertise or offer the sale or purchase of any product or service; collect or otherwise collect information about third parties, including their e-mail addresses, without their consent, as well as provide third-party e-mail addresses to third parties; use, download or copy in any other way, as well as provide (free or otherwise) to a person or entity that is not a User of the services or contents any directory of the Users of the services or contents or any other information related to Users or their use outside the context of normal use in accordance with these terms of use; try to gain unauthorized access to the services or contents, to other Accounts, to computer systems or to networks connected with them, through automatic search of passwords or by other means; interfere with the use or enjoyment of the services or contents by other Users or with the use or enjoyment of similar content by other persons or entities; perform any action on the Website that involves the transmission of any computer program that is harmful, harmful or simply not requested; include, publish, send by email, transmit, or otherwise make available any content that you do not have the right to transmit by law or under contractual or fiduciary relationship (such as internal and / or confidential information acquired or delivered as part of employment relationships or confidentiality contracts); upload, publish, send by email, transmit, or otherwise make available any content that violates any patent, trademark, trade secret, copyright or any property right of any third party; interfere with or interrupt the Website, its servers, or networks connected to the Website, or disobey any requirement, procedure, policy or regulation. Limitation of the Liability of ECHEZ

User acknowledges that ECHEZ does not assume responsibility, whether direct or indirect, foreseen or unforeseen, for any type of damages, including loss of profit, derived from the misuse of the Website or its contents made by the User or third parties. Under no circumstances will ECHEZ be responsible for Website content, supplied by User or ECHEZ, including, but not limited to, any error or omission, or for the loss or damage of any content. The User expressly accepts that ECHEZ will not be responsible for the damages caused as a result of the failure or any discontinuity in the Website. The User expressly accepts that ECHEZ will not be responsible for unauthorized access, copies, alterations or deletions of data from the Website, or its consequences. The User accepts that ECHEZ will not be responsible for the services that third parties may provide through links from the Website, or the products or goods advertised in it. Authorization granted by User

User agrees to hold ECHEZ, its controlling entity, subsidiaries, affiliates, directors, managers and employees harmless in the event that any use of information, files or other content provided by User infringes the rights of third parties, whatever the nature of such infringement. User acknowledges that ECHEZ shall have the right to modify, alter or edit any information or file that the User has uploaded to the Website. User consents to ECHEZ use, through the Website, of the data provided by Use, in order to send information, promotions or advertising associated with ECHEZ and its services.

Data Privacy and Protection Policy, Confidentiality

All data provided by User to ECHEZ will be subject to our Data Privacy and Protection Policy, which we suggest you read carefully, available in <https://www.somsight.com/Home/DataProtection> (PPDP), which is an integral part of these Terms and Conditions, as well as all the Pages and links available on the Website that contain information that generates rights or obligations for users. By accepting these Terms and Conditions, the User is also providing consent to the applicability of the PPDP and all other obligations set forth in the terms applicable to the usage of the Website.

ECHEZ will maintain the confidentiality of the information provided by Users, unless such information is requested by a judicial or administrative authority, or if the information has already been made public by other means.

Intellectual Property

All applications, services and content provided by the Website are made available and authorized for legitimate use only. The programs, databases, networks and files that allow the User to access and use an account are the property of ECHEZ and are protected by the laws and international treaties of copyright, trademarks, patents, models and industrial designs.
